

Training, instruction, education

In order for personal protective equipment (PPE) to guarantee the declared safety, its correct handling is assumed.

To train the correct use of PPE, to instruct new employees, to refresh existing work processes or to learn new ones, various modules tailored to your needs can be offered:

Training module: Correct Handling and Safe Use of Protective Suits

Training objective:

The users learn the correct dressing, the safe use as well as the contamination-free undressing of protective suits. This is done by using the actual protective clothing available at the place of work, such as e.g.:

- unventilated protective suits, in use with protective mask (e.g. protective suits DONALD, GEMINI, WEGA)
- ventilated full protective suits with integrated ventilation system (e.g. protective suits TITAN, CORONA, URANUS)
- ventilated full protective suits in combination with the COLT/VENTO ventilation system (e.g. protective suits MARS, COMET)
- Pedi safety couplings, breathing air hoses, hose trolleys, etc.
- Breathing air filter stations AIR-BOY and AIR-JET

Target groups:

Training module 1: For users of protective suits and equipment.

Training module 2: For instructors of users of protective suits and equipment.

Training location:

The training can be carried out directly on site or at Pedi AG in Oberentfelden.

For on-site training, the protective equipment and a breathing air connection (approx. 6 bar) have to be provided.

Training programme:

The training includes a theoretical part (approx. 1 hour) and a practical part (approx. 3 hours).

Proof of training:

The participants of these training modules receive an "user certificate" or an "instructor certificate" with listed, instructed utensils.

Costs:

The training costs are calculated according to the service tariff and include all necessary documents, documentation and the training certificate.



Regular maintenance and repair work ensures that components are always ready for use and safe operation.

**Training module:
Maintenance and repair works on Protective Equipment**

Training objective:

The equipment managers learn:

- Inspection and cleaning of the equipment used
- Disassembly
- Replacement or repair of defective components
- Assembly and leak test
- Function control and creation of a test protocol

Target groups:

Training module 3: For equipment managers in the field of protective suits and equipment.

Training module 4: For instructors of equipment managers in the field of protective suits and equipment.

Training location:

The training preferably takes place at Pedi AG in Oberentfelden, but can also be carried out on site. For on-site training, the equipment and protective equipment, the necessary assembly tools and a breathing air connection (approx. 6 bar) have to be provided.

Training programme:

The training includes a theoretical part (approx. 1 hour) and a practical part (approx. 5 hours).

Proof of training:

The participants of these training modules receive an "equipment manager certificate" or an "instructor certificate" with listed, instructed utensils.

Costs:

The training costs are calculated according to the service tariff and include all necessary documents, documentation and the training certificate.
